The court was formed by the merger of the U.S. Court of Customs and Patent Appeals and the appellate division of the U.S. Court of Claims. The Federal Circuit has nationwide jurisdiction in a variety of subject areas, including international trade, government contracts, patents, trademarks, certain monetary claims against the United States government, federal personnel, veterans' benefits, and public safety officers' benefits claims. The court is located in the Howard T. Markey National Courts Building on historic Lafayette Square in Washington, D.C.
